

## ecoAWARDS Terms and Conditions• Ecoforest

---



The ecoAWARDS recognise the best installations made with Ecoforest heat pumps to promote their installation and promote good practices related to energy efficiency. The awards recognise the quality of the project and the information provided. Heat pump installations will compete in the categories of domestic installations and high-power installations. All projects that comply with the Rules will be considered. A committee of experts will evaluate the quality of the submitted projects. Participation will be free of charge.

### 1. Acceptance of rules.

By entering the ecoAWARDS competition (the “Competition”), you hereby accept all the present Terms & Conditions and warrant that all the information submitted by you is true, current and complete. A committee convened by Ecoforest reserves the right to verify the eligibility of all participants.

### 2. Theme of the competition.

The participants will send information, images and videos showing the quality of air conditioning installations that include at least one Ecoforest heat pump. The categories of the projects are:

- Best domestic installation (More info on “6. Selection criteria).
- Best high-power installation (More info on “6. Selection criteria).

### 3. Eligibility

The Competition is only open to Ecoforest clients and installers with an active customer file in the moment in which the call for entries will be published. Projects can only compete once, without any possibility to participate again in the next editions.

Only the equipment mentioned in Annex I will be admitted in the competition. All other equipment will be excluded.

Ecoforest reserves the right to restrict participation or disqualify any entry for any reason including, but not limited to, any violation of these official terms and conditions, or any disruptive, unethical or illegal conduct.

### 4. Participation

Interested participants will fill in the form available on the website <http://www.ecoforest.com/en/ecoawards-heat-pumps> with the required information.

Deadline is the 22<sup>th</sup> of September 2023 at 08:59:59 CEST. The jury will take into account the submission of graphic materials (photos, videos...) that show the complexity, efficiency and innovation of the installations.

By participating in the competition, participants certify that they have read, understood and agree with this Terms & Conditions. Participation is free and Ecoforest will never charge participants.

## 5. Languages.

With the aim of supporting communication, materials should be sent in Spanish, English, Italian and French. In case of sending any materials that will not be available in these languages, Ecoforest may request their translation into English.

## 6. Selection criteria

The expert criteria will rate installations in accordance with the following criteria:

- Submitted information on the installation (description, list of components, photos or videos).
- Innovation: the capacity for satisfying energy demands in an innovative way.
- Efficiency: the energy-saving capacity compared to similar installations running on fossil fuels.

## 8. Amount of the prize.

- Best domestic installation. Best Project with a heat pump not belonging to the high-power range and that presents a high-efficiency thanks to the use of different technologies developed by Ecoforest.
  - o Trophy and commemorative diploma.
  - o Air travel and hotel accommodation for four people to the Balearic Islands or similar destination.
- Best high-power installation. Best high-power heat pump installation showing a high-efficiency thanks to the use of different technologies developed by Ecoforest.
  - o Trophy and commemorative diploma.
  - o Air travel and hotel accommodation for four people to the Balearic Islands or similar destination.

The travel will be subjected to availability and may be substituted by a similar value experience. The winners will be responsible for any other expense not mentioned in the Terms & Conditions.

## 9. Acceptance of rules.

The winners cannot assign or transfer their award to any person or entity. Any expense not specified in these terms and conditions (including, but not limited to, fees or any other costs or charges related to the participation in the Competition and the acceptance and/or enjoyment of the prize) are the solely responsibility of the participants.

## 10. Recognition.

All Participant authorise Ecoforest to use, reproduce, disseminate, publish and distribute the winners name(s) by any means of communication or media with the aim of promoting the competition.

## 11. Intellectual property of submitted materials.

All Participants will retain the intellectual rights of videos, photos, texts and any other material sent as part of the project candidature. By entering the Competition all Participants grant Ecoforest non-exclusive, global, illimited and royalty-free rights for the purpose of marketing, promotional, informational, educational or awareness-raising activities, by means of print, digital or online media, including the Organiser's websites. The Participants warrant that they have the necessary legal rights to grant this permission to the Organiser.

All Participants agree to release the Organization from and against any claims, expenses and liability, including negligence and damages of any kind to persons and property, infringement of trademark, copyright or other intellectual property rights linked to their participation in the Competition and the contents of their submissions. The Spanish courts will have jurisdiction over any dispute arising in relation to these Terms and Conditions or in relation to this Competition.

Any personal information, including, but not limited to, the participant's name, age, address (including postcode), mobile phone number and/or email address will be used solely in connection with this Competition and will not be disclosed to any third party except for the purpose of the Competition.

Management of personal data will take into account the provisions of the Spanish Organic Law 3/2018 (5 December) on Personal Data Protection. The Organizer is not responsible for lost, late, corrupted, mutilated or misdirected submissions or submissions not received in time for judging.

## 8. Early termination of the contest.
